

ENVIRONMENTAL COMMITMENT OF THE MANAGEMENT

With the intention of being a reference in the development of the economy of Barcelona and Catalonia, the Consorci de la Zona Franca de Barcelona (CZFB) maintains its commitment to manage its offices and common areas of the industrial estate, the Nexus II building, the Media-Tic, and the DFactory, contributing to 6 of the sustainable development goals agreed upon at the United Nations Summit on Sustainable Development.

Through this statement, the CZFB wishes to inform the employees of this Consortium, government bodies and member entities, clients, suppliers, civil society, and all identified stakeholders of its commitment and respect for the environment. This commitment is outlined in the following principles of action:

1. Implement a planned environmental management, appointing leadership and responsibilities for the organization's environmental aspects and allocating the necessary economic and human resources for continuous improvement of our environmental performance.
2. Provide the environment and take action, control, and correction measures necessary to understand, prevent, and continuously improve the direct and indirect environmental impacts of our current or future activities. Evaluate the risks and opportunities associated with them by analyzing the life cycle, if applicable.
3. Support initiatives that contribute to reducing the environmental impact of processes and actions, whether they are our own or those of third parties, considering the risks, opportunities, and significant impacts that the activities may generate.
4. Ensure compliance with current environmental regulations and other environmental requirements voluntarily acquired by the CZFB and make it public. Monitor this compliance, assessing the risks and opportunities that may arise from this regulation.
5. Define and periodically review objectives and milestones to comply with our environmental policy.
6. Train, sensitize, and involve Consortium employees, making them part of environmental management. Transmit our environmental guidelines to suppliers, subcontracted companies, and tenants, involving them in the continuous improvement of the Consortium's environmental behavior (SDG 17. Partnerships for the Goals).
7. Promote internal and external environmental communication with transparency criteria, informing government bodies and member entities, clients, and all stakeholders of the environmental protection measures taken and the environmental policy.
8. Protect the environment and prevent pollution through sustainable use of natural resources, efficient use of water and energy, and promotion of waste reduction, reuse, and recycling practices (SDG 6. Clean Water and Sanitation, SDG 7. Affordable and Clean Energy, SDG 12. Responsible Consumption and Production, and SDG 13. Climate Action).
9. Encourage circular economy concepts based on industrial symbiosis that stimulates collaboration between businesses in the same territory (traditionally unrelated) to generate new business opportunities by exploring innovative ways to implement them (SDG 9. Industry, Innovation, and Infrastructure, SDG 12. Responsible Consumption and Production, and SDG 17. Partnerships for the Goals).
